It is noted that JETSTREAM will provide a copy of the personal data upon submission of the relevant request, but for any additional copies it shall retain its right to impose a reasonable cost.

Your aforementioned data when completing the form, shall be used by JETSTREAM solely for the examination and fulfillment of your request. Depending on the nature of your request, your information shall be forwarded to the appropriate departments of the Company for the assessment and timely fulfillment of the request.

JETSTREAM shall make every effort to take all necessary actions within thirty (30) days of the date that you exercised your right, unless the work concerning the fulfillment of your request is characterized by particularities and / or complications, under which JETSTREAM shall reserve the right to extend the time for the completion of the actions. In any case, you shall be notified within one month of your request's submission for its progression and any extension of the response.

The request with your information shall be retained for five (5) years by JETSTREAM, subject to prolongation of the relevant time period in the event of exercise of legal claims.

In case you believe that the exercise of your right is not fulfilled, you reserve the right to have recourse to the Data Protection Authority (www.dpa.gr).
